6. Modem Installation to DTCs

- a) Honorable ACS and MD BESCOM instructed ITIA to fix the modems for DTCs also since PFC is compulsorily insisted the same, in the meeting held on 10/11/2014. Further instructed to go with 2-3 different make modem vendors as suggested by PFC New Delhi.
- b) ITIA expressed that the contract with the modem vendor M/s ERL has been terminated due to the nonperformance and no progress shown in field.
- c) Further ITIA expressed that they are already working with M/s Analogics, for modem installation across ESCOMs for HT and Boundary meters.
- d) ITIA also expressed about one more technology of RF technology with DCU as an alternative for fixing the modems to DTCs and should be tested in the field as a POC. Further ITIA expressed due to financial issue for replacing the ERL modems they need time up to FEB-15 to finalize the issue.

7. Meeting to be conducted with all R-APDRP town AEEs in ESCOMs.

a) Honorable MD BESCOM instructed to all other ESCOM MDs to conduct the meeting with all AEEs/AE(T)s & AAOs of R-APDRP town in ESCOMs, to find out and resolve the issues of unrealistic EA reports which were send to PFC.

8. ACS Energy instructed ESCOMs on the following:

- a. Close all the issues pertaining to Third Party Payments.
- b. Release pending payments to ITIA for all the deliverables complied by ITIA
- c. GM(IT) to write a letter to ESCOMs on the payment towards the Installation, Configuration & Customization of Application Software
