What is the human cost of a case in which the accusa-tion eventually turns out to be motivated or false? A recent case of acquittal of two state government offi-cials shines some light on the question.

During the pendency of the trial, both the kidneys of the main accused failed; and the second accused had to undergo two heart operations. Both now have two years of service left and are glad that despite the case going on for nine years, they will now retire with a clean bill of service.

ciai court judge Manjunath Summing said that it was obvious that the charges were cooked up and the police should have been more careful; they should have vetted the case before

One Aravind Kumar, an electrical contractor, had lodged a complaint with the Lokayukta on September 25, 2008, alleging that RB Shivaraj, now 58, (who was charged as the main accused) had demanded a bribe of Rs 200 to issue an electrical conmactor's accesse to the for-mer. Shivaraj was an accountant in the electrical mspectorate onice

A Anand, also 58 now, a

first division assistant in the same office, was made accused number 2 in the case even though his name did not figure in the initial complaint. HV Sreenivas, a social welfare department staffer, was made the shadow witness and a certain Mohammed Irshad was the investigating officer in the case. The Lokayukta police claimed that the trap laid on the two on September 25, 2008, was successful

(An electrical contractor licensed by the government is a big deal; such contrac-

tors can earn in crores if they win a government ten-der or in lakhs if they get small contracts like electri-fication of a new construction. A bribe of a mere Rs 200 for such a licence prima facie looks like somebody's attempt to fix the accused.)

The investigation During the trial, multiple versions by the IO, witness and the accused proved

that something was amiss. Kumar, the complainant alleged that he had left Rs alleged that he had left Rs 500 on Shivaraj's table after he refused to accept the bribe. He also alleged that he had given Rs 200 to Anand (accused No. 2) on his way back and Anand had kept the money on

Shivaraj's table. However, the IO alleged that the demand was for Rs 200; the same amount was given to the complainant when he approached the accused.

The shadow witness Sreenivas, on the other

version and said that Rs 500 had been paid. Interestingly, he admitted during trial that he was a repeat witness and com-plainant; he was a witness in five cases and a com-plainant in nine.

The clincher came from the mahazar (record of proceedings or recoveries during a raid/incident) which recorded Shivaraj as telling the accused "I know what you are up to. Get out of here," when he approached him with the marked currency notes

Despite the loopholes in the case, a charge sheet was filed on February 2, 2010.

The trial stage

When the case went to trial, it became increasingly clear that the accused had been fixed. The complainant failed to turn up for cross examination from January 2013 till December 2016. The hand wash of

He left home at 5 am and walked for over a kilome-tre before climbing up to sit on a transformer on the outskirts of the vilthe outskirts of the village. There was no power supply at the time, but he was aware it would resume at 8 am and waited patiently for it and got himself electrocuted. The suicide of 58-year-old farmer Chamansab Arisinaguppi of Chikkansihosur village in

Arisinaguppi of Chikkamsihosur village iin Hangal taluk of Haveri district on Friday left the people here shocked. He was believed to be depressed over the failure of his crops for two consecutive years and the harassment he was suffering from moneylenders. The people, who rushed to the transformer on hearing a loud noise, saw

hearing a loud noise, saw him lying there dead and realised what he had done. Chamansab owned three acres of land and had

Struggling to make ends meet owing to the drought, he had grown jowar by taking a loan from the State Bank of India, but could not repay it as the crop failed. He then borrowed from moneylenders on higher interest to repay the bank, but it refused to give him a

Mysuru & Hassan railway stations 19 to get solar power

Mysuru and Hassan railway stations will soon have solar panels installed on the roof. It is part of an all-India initiative by the Ministry of Railways. In Mysuru Railway division, Mysuru and Hassan stations will soon allot space to private parties on the roof of station premises for setting up the panels.

Both stations will have solar panels

with a 200 kw capacity unit generating 2000 units of electricity every day.

Sources from Railways told Bangalore Mirror that the two stations are now getting electricity from the Karnataka Electricity Board (KEB). After solar electricity generation begins at the plants,

tricity generation begins at the plants, they will buy the electricity from the company that installs the plant at a lower price. Officials said the cost could come down by Rs 1 lakh per month.

The solar plant is expected to be installed within 6 months. Atul Gupta, Divisional Railway Manager, said, "It is very easy to install. Soon afterwards, we will get power at a reasonable price."

Officials of the company which has won Officials of the company which has won the tender have identified the spots where plates can be installed.
